Addendum #1 Overview

This Addendum #1 addresses questions received on the RFP.

Addendum #1 Questions and Answers:

Q1: Whether companies from Outside USA can apply for this?
(like from India or Canada)

A1: I do not believe that there is an express residency requirement for the underlying entity or team.

- However, to the extent that this would result in either a lack of availability or familiarity with the issues the County is seeking representation on, that may impact the scoring per the criteria.

Q2: . Whether we need to come over there for meetings?

A2: Please refer to the scope of services which mentions coordinating local, state and federal intergovernmental relations and refers to attending briefings, meetings and project/program events.

Q3: Can we perform the tasks (related to RFP) outside USA?
(like, from India or Canada)

A3: In bulk or systematically, no. That would conflict with the scope of services. If somebody is on vacation or split time and does some work remotely, that happens

Q4: . Can we submit the proposals via email?

A4: No, pursuant to the submission criteria on page 2.

Q5: Is the County looking for a **single** “General Lobbyist” to provide services at the federal, state and local levels? Or, can an applicant provide services on one level with the ability to coordinate on all levels?

A5: Santa Cruz County has the discretion of selecting one or more firms that provide the services in the scope of services. The firm or firms selected are not required to provide all of the requested services listed in the scope of services.

Q6: Regarding the mandatory pre-submittal meeting on April 28th, must that be attended in person? Or is it possible to participate via zoom, or telephonically?

A6: Santa Cruz County will allow participation via Zoom. Zoom meeting link (from IT)
