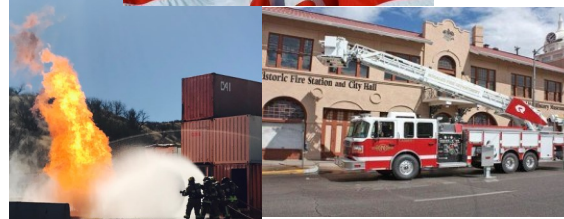


REMS (Readiness Emergency Management System)

Santa Cruz County School Superintendent's Office



The Santa Cruz County School Superintendent's Office serves as the fiscal agent to all school districts within our jurisdiction and acts as a liaison to the Arizona Department of Education.

Emergency Preparedness

In collaborating with all the schools in the County, the School Superintendent's Office established a comprehensive Emergency Preparedness Plans using the REMS (Readiness Emergency Management System).

The goal for this plan is to improve, expand, create, and maintain safer schools for all students throughout Santa Cruz County.

REMS (Readiness Emergency Management System) for schools

The REMS system is web-based database that includes site graphics, photographs, digital exit floor plans and other visuals to fully describe all school facilities, surrounding areas, contact information, locations and staging areas to make these instantly available to first responders (police department, fire department, sheriff's office) during a crisis.

The website is updated twice a year to ensure accurate information is provided to those first responders during a crisis situation.

Funding Source

In 2007 Santa Cruz County School Superintendent's Office received funding for the REMS Program through the United States Department of Education, Emergency Response Plans for School Safety Initiative.

Being a border community, our school districts must be prepared for the possibility for any type of emergency. Due to the importance of the program, Santa Cruz County School Superintendent Alfredo I. Velásquez and his office staff have covered the cost of the program since the grant ended in 2009.



REMS (Readiness Emergency Management System) Partnership with Santa Cruz County School Districts

The purpose of this web based plan is to mitigate, prepare, respond, and recover from an emergency incident through the expertise of a broad base of community first responders and critical partners, involving schools, students and community stakeholders in all phases of emergency planning.
